पावसाने हजेरी लावली. बिपरजॉय गुजरातला धडकण्यापूर्वी दोघांचा मृत्यू झाला होता. वादळ धडकल्यानंतर राज्यात एकाचाही मृत्यू झाला नसल्याचे एनडीआरएफचे महासंचालक अतुल करवाल यांनी शुक्रवारी सांगितले. जीवितहानी टाळण्यासाठी सर्व यंत्रणांनी केलेल्या प्रयत्नांचे हे यश असल्याचे करवाल म्हणाले. वादळाशी संबंधित घटनांमध्ये २३ जण जखमी झाले. जीवितहानी टळली असली तरी वित्तहानी मोठ्या प्रमाणात झाली आहे. कच्छ, देवभूमी द्वारका, जामनगर, मोरबी, जुनागड, गिर सोमनाथ, राजकोट आणि पोरबंदर या आठ जिल्ह्यांना वादळाचा सर्वाधिक फटका बसला. वादळामुळे विजेचे ५१२० खांब कोसळले. त्यामुळे ४६०० गावांचा वीजपुरवठा खंडित झाला होता. शुक्रवार संंध्याकाळपर्यंत काही गावांचा वीजपुरवठा सुरळीत करण्यात विद्युत विभागाला यश आले असले तरी अद्यापही १००० गावांचा अंधार आहे. सुमारे ५०० झोपड्या, कच्चा घरांचे नुकसान झाले. काही पक्क्या घरांचीही पडझड झाली. ८०० झाडे कोसळल्याने अनेक रस्ते बंद झाले. एनडीआरएफ व एसडीआरएफचे जवान युद्धपातळीवर मदत व बचाव कार्य करत आहेत. परंतु पाऊस व सोसाट्याच्या वाऱ्यामुळे बचाव कार्यात अडचणी येत आहेत.

गुरुवारी संध्याकाळी सहा वाजण्याच्या सुमारास गुजरातच्या जखाऊत चक्रीवादळाचा लँडफॉल झाला. रात्री अडीच वाजेपर्यंत ही प्रक्रिया सुरू होती. वादळामुळे १४० किमी वेगाने वारे वाहत होते. मुसळधार पावसामुळे सखल भागात पाणी साचले. जमिनीला धडकल्यानंतर वादळाचा वेग व तीव्रता हळूहळू कमी झाली. संध्याकाळपर्यंत वादळाचे कमी दाबाच्या क्षेत्रात रूपांतर झाले. वादळ राजस्थानमध्ये पोहोचण्याची शक्यता अगदीच नगण्य असली तरी शुक्रवारी जालोर, बाडमेरमध्ये मुसळधार पावसाला सुरुवात झाली. बिपरजॉय पाकिस्तानला धडकण्याची शक्यता होती. मात्र वादळाचा जोर गुजरातमध्येच ओसरल्यामुळे पाकच्या किनारपट्टीवरील लोक आपल्या घरी परतू लागले आहेत.
